Here is an up date on our Carbonera water project. I have also attached the poster, you may be able to use it a future issue of the Blastoff. Progress continues to be made on the project in Carbonera, Mexico. We have met with the 288 Club, West U, and League City. All three clubs going to be involved in the project. On site, Builders Without Boarders has pushed ahead and already poured the slab for the building and drilled the water well.
