
Hilmar R. Zeissig was born the year before World War II in Berlin, Germany and grew up in a small village at the Dutch border in Northern Germany. His father was killed as a Major of the German Infantry in the suburbs of Moscow in early 1942. After graduating from high school Hilmar served in the newly established German Army in 1958/59 and later in the reserve during his college vacations, obtaining the rank of a First Lieutenant. He studied geology, business administration and law at the Universities of Kiel, Bonn and Cologne (Germany), Lausanne (Switzerland) and Santiago (Chile) and graduated with the First Law Degree (BS equivalent) in 1965. After obligatory internships at various courts, state revenue service and several law firms, he received his Second Law Degree (MS equivalent) and a Ph.D. in International Law in 1969.

Zeissig spent the first part of his career as chief negotiator for the German national oil company DEMINEX and later as General Manager of their oil and gas exploration and production operations in Peru, drilling wells in the Amazon Jungle, and in Egypt, running two offshore rigs in the Golf of Suez. He moved to Houston, Texas in 1978 as President and CEO of a domestic exploration company owned by the German steel concern Salzgitter. From 1981 to 1995 he ran independent oil companies which he formed with local partners and foreign investors.

In 1982 he also established the consulting firm Houston International Business Corp. as advisor to major corporations in structuring and evaluation of new business ventures as well as in the selection and acquisition of services and supplies for energy and environmental investment projects in the U.S. and abroad. Since 1986, he has been the project director or lead consultant in energy sector reform projects, particularly in the petroleum sector, in more than 30 developing countries for The World Bank, the United Nations' Economic Commission for Latin America and the Caribbean (ECLAC), the United Nations Development Agency (UNDP), the Inter-American Development Bank, the United States Agency for International Development (USAID), the U.S. Trade and Development Agency (USTDA), the German Technical Cooperation Agency (GTZ), other bilateral and multinational institutions and governments in all continents.

He is a well known expert for legal, regulatory and institutional matters in connection with the privatization and reform of the petroleum sector, structuring and organization of monitoring and enforcement functions, design and implementation of safety and environmental standards, as well as petroleum supply strategy and general energy policy. Modern laws and regulations for the oil and gas sector, drafted by him, are in force and effect in Nicaragua, Guatemala, Madagascar and Uganda and in the legislative process in several other countries. He has also worked in electricity sector reform projects in Colombia and China and has played a leading role as project coordinator in two of the largest urban air quality improvement programs in the Metropolitan Areas of Mexico City and Santiago de Chile. Presently he is working on consulting projects in Afghanistan, Jordan, Yemen and Palau, Micronesia.

Hilmar is still a German citizen and a US legal resident. He is fluent in English, German and Spanish. Since he came to Texas, he has been very active in many professional associations and community service organizations, among others, as Chairman of the German-American Chamber of Commerce (1993-97), Director of the World Trade Division of the Greater Houston Partnership (1980-1996), Charter Member of the International Board of Texas A&M University since 1993 and on the Community and Economic Development Committee of the City of Friendswood. Hilmar has been a Rotarian since 1974, first in the Rotary Club of San Isidro



in Lima, Peru, then in the Rotary Clubs of Houston, Sugar Land and Space Center since 2004. Among many other activities, he served as GSE Team Leader to Mexico in 1986, District 5890 GSE Chairman 1986-1996, International Chairman 1997-2008, Tsunami Relief Chairman 2004/05, Discovery Grant Team Leader to Chile and Thailand and as consultant to RI to write the official GSE Planning Guide. He received the RI Service Above Self Award in 2006, the District Service Award 2006-2007 and obtained three Paul Harris Fellowships, including one for his youngest son who was the founding President of the Interact Club at Awty International School in Houston.

Hilmar is married to Rose, he has a daughter and three sons, and she has six daughters from previous marriages. They have 16 grand children with two more on their way, and four great grand children. After living in Sugar Land for 25 years, Hilmar moved to Friendswood in 2004. Sailing has been his life long hobby, he owned several beautiful boats and is now bareboat chartering locally and internationally, next time on May 24, 2008 in the Adriatic Sea of Croatia.
