MINUTES OF THE BOARD OF DIRECTORS MEETING

OCTOBER 29, 1969

THE DIRECTORS AGREED THAT FUTURE BOARD MEETINGS WOULD BE HELD ON THE 2ND AND 4TH WEDNESDAY OF EACH MONTH. THE MEETING WILL BEGIN AT EITHER 11:30 A.M. Or 11:45 A.M. AND WILL BE CONCLUDED AT APPROXIMATELY 1:00 P.M. A SCHEDULE WAS PRESENTED BY PRESIDENT HOBART OF FUTURE MEETING DATES AND THE PARTICULAR COMMITTEE CHAIRMEN WHO WILL BE ATTENDING EACH MEETING.

PRESIDENT HOBART WROTE A LETTER TO JACK HOLM AND BOB COLOPY INFORMING THEM THAT THEY WERE BEING DROPPED FROM THE ROTARY CLUB DUE TO LACK OF ATTENDANCE. JACK HOLM REPLIED AND EXPRESSED HIS REGRETS BUT STATED THAT BUSINESS OBLIGATIONS MADE IT VIRTUALLY IMPOSSIBLE FOR HIM TO ATTEND REGULARLY. BOB COLOPY REPLIED AND ASKED THAT HE BE RE-INSTATED TO MEMBERSHIP. HE EXPLAINED THAT HE WOULD BE ALBE TO ATTEND MEETINGS ON A REGULAR BASIS. THE BOARD VOTED UNANIMOUSLY THAT MR. COLOPY'S REQUEST BE GRANTED.

THE CHAIRMAN OF THE CLASSIFICATION COMMITTEE, REX STRADER, WAS PRESENT AND DISCUSSED PROCEDURES OF HIS COMMITTEE AND THE MEMBERSHIP COMMITTEE REX MENTIONED THAT ALL MEMBERSHIP APPLICATIONS WERE NOT BEING ROUTED PROPERLY TO HIS COMMITTEE.
