

New Business:

Eye Clinic:

Located at the orphanage in Guerro, Mexico, there has been \$21,000 pledged for the clinic. Earl Maudlin and Johnny White will underwrite all or part of a \$2,000 commitment unless the club donates all or part of the commitment. In addition a washer/dryer is also needed and the approximate cost is \$1,000. Total needed for both commitments is \$3,000.

David Coney made a motion to fund the \$2,000 and Rae DeCastro – second. Mike Dennard suggested that the project is presented to Dick Kidder to figure out the funding through the World Health Budget section. Motion carried unanimously.
