# RULES CHANGE

## Proposed Amendments to the Bylaws of Space Center Rotary

### Article I. Section 3.

A vacancy in the board of directors or any office shall be filled by action of the remaining members of the board. *In selecting a director to fill an unexpired term, consideration shall be given to those nominees for election who, at the most recent election of directors by the club members, were not elected. However, the board shall not be required to make its selection from those members only, but may consider any club member who is proposed by a member of the board.*

### Article II. Section 6.

*Members of the board are expected to attend all meetings of the board unless, for good cause, they are unable to do so. If a board member knows prior to the day of any meeting that he/she will not be able to attend that meeting, the board member should so notify the club secretary or president. Further, if the board member is able to do so, he/she should arrange for another member of the board or one or more of his/her committee chairpersons to make any reports that the board members who will be absent is scheduled or expected to give at the board meeting which he/she will miss.*

*If any member of the board is absent from three (3) or more consecutive regular meetings of the board or, after having been a member of the board for a minimum of three (3) months, shall for any period of time have been absent from more than fifty percent (50%) of the board meetings during the time he/she has been a member of the board, that board member may be removed from office by the remaining members of the board acting at any regular meeting or at a special meeting called for that purpose. In either event, the board member whose removal is being considered shall be given not less than seven (7) days written notice prior to the regular or special meeting at which a vote will be called for a motion for his/her removal. Prior to voting by the board on such motion for removal, the board member who is being considered for removal, if present, shall be given an opportunity to explain his/her absences and request that he/she not be removed. The vote on the resolution for removal shall be a written ballot. As soon as possible following an affirmative vote for removal of a board member, the secretary shall notify such member that he/she has been removed. An appeal of the board's decision to remove a board member may be made to the Club in accordance with the provisions of Article VIII. Section 2. of the Constitution of the Club.*
